Bids may be hand delivered in a sealed envelope, or emailed to Brenda Dowlatshahi, at <u>bdowlatshahi@tricountyri.org</u> no later than 3:00 pm on Wednesday, September 26, 2023. Bids may also be mailed, and must be in hand, or received in the mailbox at the address indicated by the above deadline. It is the bidder's responsibility to ensure that bids are received in time. Delays that occur due to traffic or the internet will not be considered, therefore we recommend that you do not wait until the last minute to submit.
